Created in 2001, in Luxemburg, the European
Bar Human Rights Institute (IDHAE) has as its
objective:

- the monitoring of human rights protection
particularly under the European Convention of
Human Rights and Fundamental Freedoms of
November 4th, 1950 and its Protocols as well as
the Charter of Fundamental rights of the
European union.

- the training of lawyers in international human rights law particularly relating to the rights of the defence before the international jurisdiction and criminal courts.

- interventions, regardless of the limitations of borders, in favour of freedom and the fundamental rights of lawyers with its World Observatory for Defence Rights and attacks against lawyers : "*Attorney Urgent Alert*."

- the organisation of workshops, symposia and seminars related to publications on international human rights law.

The IDHAE participates, in partnership by other institutes members, to the granting the "*International Human Rights Prize Ludovic Trarieux*" awarded every year to " a lawyer, regardless of nationality or Bar, who throughout his career has illustrated, by his activity or his suffering, the defence of human rights, the promotion of defence rights, the supremacy of law, and the struggle against racism and intolerance in any form ". The award is presented every year in a city that is home to one of the member Institutes.

It is the oldest and most prestigious award given to a lawyer in the world. It commemorates the act by the French lawyer, Ludovic Trarieux (1840-1904), who founded, in 1898, in the midst of the Dreyfus Affair in France, the " League for the Defence of Human Rights and the Citizen".
